	Option A = Recording of an artistic performance for assessment. The recording must not be archived and it must be destroyed after the assessment and approval process.
	Option B = Recording of an artistic performance for assessment. The recording will be kept in the Theatre Academy library with the written section of the thesis. The recording can be viewed on the library premises, but it cannot be stored or copied.
